**NOTICE IS HEREBY GIVEN THAT**, pursuant to Section 6586.5 of the California Government Code, the City Council (the "City Council") of the City of Scotts Valley (the "City") will hold a public hearing on Wednesday, June 19, 2019 at 6:30 pm or thereafter, at the City Council Chambers located at 1 Civic Center Drive, Scotts Valley, California, in respect of the proposed refinancing of certain public improvements, by the issuance and sale of bonds by the Scotts Valley Public Financing Authority, and the significant public benefits to the City from the proposed refinancing in accordance with criteria specified in Section 6586 of the California Government Code.

Those wishing to comment on the proposed refinancing may either appear in person at the public hearing or submit written comments which must be received by the City Council prior to the public hearing.
