COMMITTEE REPORTS

VM Lind announced that Assembly Member Bill Monning is co-hosting a Senior Scam Stopper Seminar in Santa Cruz at the Santa Cruz Police Department on Saturday, July 9, 2011 from 10:30 am to 12:30 pm.

Mayor Bustichi reported that the Economic Subcommittee met with representatives of Bay Photo who are interested in moving to back Scotts Valley.

CM Johnson reported that the Skypark Subcommittee met to review the status of tasks associated with the Town Center project.

CM Aguilar reported that the League of California Cities Board of Directors met via conference call to discuss the two bills recently signed by the Governor, AB 1X26 and AB 1X27, and the League voted unanimously to move forward with a lawsuit against the State, which will be going directly to California Supreme Court. She announced that the State also passed another last minute piece of legislation that takes away local vehicle license fees.

PUBLIC COMMENT

Gene Michelak, Scotts Valley Neighbors Against Smart Meters, reviewed the steps they have taken in opposition to Smart Meters and requested that the City adopt an ordinance opposing the installation of Smart Meters.

VM Lind announced that Saturday, July 16, the Annual Cops and Rodders car show/event will be held at Siltanen Park from 7:00 am to 2:00 pm.

CM Reed announced that the Scotts Valley Education Foundation (SVEF) will hold its second annual Community Day event on September 10, 2011, which is where participating local merchants will give back to schools by pledging a percentage of their sales on that day to go to the SVEF. CM Reed announced that the City of Scotts Valley will be holding a Community-wide garage sale on September 10, 2011, and stated that the City will facilitate advertising, and a master list will be made available to the public. CM Reed announced that the next free Music in the Park event, sponsored by Scotts Valley Kiwanis and the Scotts Valley Arts Commission, is being held on July 31, 2011 at Skypark. He stated that proceeds from concession sales go to benefit local schools and children.

CM Aguilar thanked the Scotts Valley City staff and the community for a wonderful 4th of July celebration.

REGULAR AGENDA

1. Discussion: Options for legally separating the Redevelopment Agency's 9,000 square feet of vacant commercial space from the new library at 251 Kings Village Road, APN 022-211-80

Agency Counsel Powell presented the written staff report and responded to questions from the Board.

To proceed with Alternative 1, Subdivide to Suit, where the Agency will complete the "Tentative Map", which allows the Agency to market the space to developers as a "subdivide to suit" property and provides the most flexibility to subsequently subdivide the commercial space into additional condominiums.

2. Skypark Open Space Maintenance Assessment District No. 1: Resolution No. 1555-SP-23; Annual Engineers Report Skypark

CM Reed stated that he lives within this assessment district and recused himself from consideration of this item.

PWD Anderson presented the written staff report and responded to questions from Council. He stated that no action from the Council is required at this time. PWD Anderson stated that this public meeting is being held to accept public testimony and that Council will consider approval of Resolution No. 1555-SP-22 at the public hearing set for July 20, 2011.

Sheryl McKewan, Skypark homeowner and landscape contractor, requested that the City reopen the bidding process on the maintenance of the Skypark Linear Park, because she feels there are better landscape practices available than what is currently being used to protect the native plants in this area.

CM Aguilar questioned if Ms. McKewan could give an example of where native plants had been impacted.

Ms. McKewan responded that the area between the tennis courts and the play area had been mowed and native plants had been destroyed.

PWD Anderson stated that under the current contact for maintenance of the Skypark Linear Park, the current expenses exceed the revenues of the assessment district, so the City's General Fund currently subsidizes this maintenance.

CM Aguilar stated that she would be requesting a future agenda item regarding the RFP for the maintenance of the Skypark Linear Park.

3. Pinewood Estates Landscape Maintenance Assessment District; Resolution No. 1213.24; Annual Engineer's Report Pinewood

PWD Anderson presented the written staff report and responded to questions from Council. He stated that no action from the Council is required at this time. PWD Anderson stated that this public meeting is being held to accept public testimony and that Council will consider approval of Resolution No. 1213.24 at the public hearing set for July 20, 2011.

No questions from Council or comments from the public.

4. Future Council/RDA agenda items

CM Aguilar requested a future agenda item to discuss a new RFP for maintenance of the Skypark Linear Park and open space areas, that includes detailed information regarding education and experience in working with native plants.
