The City Council of the City of Scotts Valley will conduct a public hearing on Wednesday, May 4, 2022 at 6:30 p.m. seeking comments on the usage of Measure D funds as proposed in the 5-Year-Plan for FY 2022-23.

Measure D is a County-wide tax that provides funding for efforts related to maintaining and improving local roads, including pavement, bicycle, and pedestrian infrastructure for a period of ten years. 5-Year Plans are adjusted annually based on actual expenditures, updated revenue projections, proposed allowances to projects, updated project schedules, and updated cost estimates.
